It can take up to three years now for approval. In a number of cases there has been no response to an application at all, even after multiple emails and calls.

Dear Ms. Consack,

You want to understand the challenges that rehabilitators go through with the MNR.

Trust is a major one!

We know that our concerns do not go 'up the food chain' so to speak.

They get to representatives who may or may not ever come to our facilities and we don't know how far they go from there because seldom do we hear back.

Sometimes, just sometimes, we get someone who responds but can't do anything about our concerns - 'above their pay grade I guess.'

Representation.

Our concerns and challenges are never mentioned in person to a gallery of MNR personnel.

It was tried once with WiRAC (Wildlife Rehabilitators Advisory Committee) but at the first meeting we were asked to sign 'non-disclosure' papers! The whole idea behind the committee was to hold talks with the MNR and then get back to the rehabbers on what was discussed - to be able to keep everyone informed.

How would that have been possible with non-disclosures?

It was obvious this was shut down with two parts of input from the MNR - first being the non-disclosure, the second being the time lapse the MNR took to set up the meeting -2 1/2 years - for a committee that was to be used for 3 years! It was even mentioned that the committee would come to an end within 2 months!

They gave us hope and then just tossed it in the garbage like a joke.

Education of the MNR

It is no secret that the personnel from the MNR are lacking in 'hands-on education' with wildlife. Since 1996 Rehabilitators have offered to give an insight into the world of rehabbing to MNR personnel. Very, Very few have taken us up on our offer. It's like driving a car on Mario Kart and then thinking you can drive one during rush hour in Toronto without ever being in a car in your life! Yet, the MNR personnel think they have all the knowledge with ALL species of wildlife and don't seem to understand what is required from catching up the animal to releasing it or even killing it.

Wildlife

Some of the MNR personnel are happy enough to stand far enough away from cages that contain wildlife, some are stupid enough to want to go into those cages and check on that animal without knowing the consequences. I have had vets come onto my property, ones HIRED by the MNR, and watched as they were harmed by my birds because they "knew what they were doing". One vet had to take a cloacal sample and I had to show him exactly where that body part was, cause he didn't know!

Some MNR personnel will listen to you, but some it just goes in one ear and out the other..

To put it in simplistic terms, Ms Consack, we, the rehabilitators of Ontario, are the front line defense with wildlife. We see the animal at its worst, we see them struggle to live and we see them die. We also see them live and we see them released back to the wild for a second chance at life. We see things that we've learned over the years and can treat.

The key word here is to see!

And our knowledge that has grown with working with the species we chose to work with has grown with each year and each animal that comes in.

These animals are not just wildlife! They are individuals that are the key to human survival and if the governments can't work with what we do, then why are they in that sector of the government?
